# Emergency Wait for Licensed Delaware Dealerships (NEW)

- One piece per Wednesday per dealership
- Dover Dealer Section only
- $\circ$  11:00 am 5:00 pm
  - o Emergency piece can be a transfer over 90 days and not submitted to DMV
  - O Duplicate title, corrected title, title into dealership name, retain and transfer to dealership.

### MV558 (Overnight) Folders

- Folders can be submitted Monday, Tuesday, Thursday & Friday from 8:00 am to 9:00 am; and Wednesday from 11:00 am to 12:00 pm
- o Folder or Federal Express Envelope MUST indicate "MV558" on the outside; if not folder will be entered as a drop
- o Piece must have been already submitted to the DMV and the MV558 must be attached
- o 2 customers per folder; include worksheet
- One folder per dealership per day

#### 5 Day Folder

- o Folder that can be submitted, with up to 5 customers that will be processed in 5 days.
- o Folder or Federal Express Envelope MUST indicate "5-Day" on the outside
- o Folders without "5-Day" on them will be submitted as drop
- o Folders that contain initial title work; the entire folder will be submitted as drop
- o Folder must include a worksheet & payment
- o Folder can only contain titles that need to have the plate placed in retention/pending and transferred to the dealership's name for the resale of the traded vehicle
- o Folder can contain "emergency" type of transactions such as duplicate titles, u-titles with a bill of sale from the dealership or a corrected title.
- o Folder can contain a title transfer that is over 60 days old and had a lien release with in the last 15 days
- o Multiple folders of 5 pieces can be submitted

### **Drop Folders**

- o Folders are limited to 5 customers per folder; no limit on folders dropped at a time
- o Folder must include worksheet & payment
- o Folders are accepted Monday through Friday during normal business hours
- Notes for processing must be written on the MV212 or title such as: issue new plate or order duplicate plate
- O Do not put notes on flyers or on post it notes in folders; Associates follow instructions on the MV212 and on the back of the Delaware title
